- A dividend of \$0.53 per share of the company's common stock, payable on June 28, 2019, to common stockholders of record at the close of business on June 13, 2019; and
- A dividend of \$1.0675 per share of the company's 8.54% Series Q Cumulative Redeemable Preferred Stock, payable on July 1, 2019, to Series Q stockholders of record at the close of business on June 18, 2019.

The following proposals were approved at the company's 2019 annual stockholder meeting: to elect twelve directors to the board of directors to serve until the next annual meeting of stockholders and until their successors are duly elected and qualified; advisory vote to approve the company's executive compensation for 2018; and to ratify the appointment of KPMG LLP as our independent registered public accounting firm for the year 2019.

Our stockholders elected Hamid R. Moghadam (chairman), Cristina G. Bita, George L. Fotiades, Philip L. Hawkins, Lydia H. Kennard, J. Michael Losh, Irving F. Lyons III, David P. O'Connor, Olivier Piani, Jeffrey L. Skelton, Carl B. Webb and William D. Zollars as directors of the company.
